

# **Official Rules**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING A PRIZE. VOID WHERE PROHIBITED BY LAW.

### **1. DATES OF PROMOTION**

The Contest period ("Contest Period") is from 12:00 a.m. Central Time (CT) on April 1, 2025 ("Sweepstakes Start") to 11:59 p.m. Central Time (CT) on June 30, 2025 "Sweepstakes End"). Sponsor's computer is the official time keeping device for this Contest.

#### 2. ELIGIBILITY
